May is Military Appreciation Month





Congress designated May as National Military Appreciation Month in 1999 to encourage U.S. citizens to observe the month in a symbol of unity. It is mean to honor the current and former members of the U.S. Armed Forces, including those who have died in the pursuit of freedom. It is a special month for both those in and out of the military.

The president will make a proclamation, reminding Americans of the important roles the US Armed Forces have played in the history and development of our country. The month of May was chosen because it already has many individual days set aside to recognize the U.S. military's achievements.

Below are six of the many observances and events that are associate with National Military Appreciation month:

- **Loyalty Day**, May 1st which kicks off the month-long celebration of military appreciation. It is a day set aside for the reaffirmation of loyalty to the United States and to reflect on the proud heritage of our American Freedom
- **Public Service Recognition week** which is celebrated the first full week in May. It is a time to honor the men and women who serve our nation as federal, state, county and local government employees and ensure that our government is the best in the world.
- **Victory in Europe Day**, May 8. This was back when on May 8, 1945 the Germans throughout Europe unconditionally surrendered to the Allies. This day marked the end of World War II in Europe.
- **Military Spouse Appreciation Day**, traditionally set for the Friday before Mother's Day. This is day recognizes the important role our military families play in keeping our Armed Forces strong and our country safe.
- **Armed Forces Day**, which is celebrated the third Saturday in May every year. A single holiday for citizens to come together and thank our military members for their patriotic service in support of our country. This day honors all military branches.
- **Memorial Day,** observed on the last Monday of the month. Memorial Day honors those select veterans who paid the ultimate sacrifice in their service to our country.
- It has been a difficult year for many for the challenges that as Posts, individuals and a country try to move forward away from the restrictions imposed during the Pandemic. If you are not yet up running, please try to show your appreciation in ways that will continue to allow for the safety of your posts and its members. Hello My Fellow Legionnaires

VA expands Post 9/11 GI Bill benefits for dependents

Wow! I know I am going to give you quite a few on-line websites to go to for information, and exerts of the article dated April 28, 2021 from VAntage Point, I would like you to have *ALL* the information that I can provide involving the Post 9/11 GI Bill. The article addresses the expanded Post 9/11 GI Bill benefits to dependents. For many the opportunities to pursue education and training beyond high school is not easily able to be reached. When military members are asked why they serve, the available GI Bill education benefits are often the reason. As part of their earned benefits, active duty men and women can also transfer all or part of their Post 9/11 GI Bill benefits to their spouse and/or their dependent children. This is called Transfer of Entitlement (TOE), you can find out more by visiting (va.gov/education/transfer-post-9-11-gi-bill-benefits/). Those wishing to transfer entitlement to a dependent must be sure to do this while still on active duty.

With the recent passing of the *Johnny Isakson and David P. Roe Veterans Health Care and Bene-fits Improvement Act of 2020,* commonly referred to as Isakson and Roe, beginning January 6, 2021, service members can transfer all or part of their Post 9/11 GI Bill entitlement to their ward or foster child. This new law changes how VA administers education benefits, and more importantly, is a major step in recognizing the diversity of the Nation's military families and their unique needs. Now, even more military dependents can receive help paying for tuition, books and housing using Post 9/11 GI Bill education benefits (va.gov/education/about-gi-bill-benefits/). Eligible dependents, who are pursuing a degree or certification in the STEM (Science, Technology, Engineering and Math) fields, can maximize their benefits through the Edith Nourse Rogers STEM Scholarship (va.gov/education/other-va-education-benefits/stem-scholarship/). To help pay for higher out-of-state, private or graduate tuition that the Post 9/11 GI Bill doesn't cover, the Yellow Ribbon Program (va.gov/education/about-gi-bill-benefits/post-9-11/yellow-ribbon-program/) provides additional assistance. In addition to education and training, GI Bill benefits can provide other assistance to eligible students, such as help with paying certain test fees and help with deciding on the right school or program, using the GI Bill Comparison Tool.

National Park Access Pass



National Park Access Pass

The Access Pass, part of the America the Beautiful – National Parks and Federal Recreational Lands Pass Series, is available free for US citizens or permanent residents with permanent disabilities. Applicants must provide documentation of permanent disability and residency or citizenship. The pass may be obtained in person at a federal recreation site or through the mail using an application form. (Note: While the pass itself is free, the cost of obtaining an Access Pass through the mail is \$10 for processing the application.) Read more about the Access Pass, and other passes, below. Please note that passes are not available at all national parks; see a <u>list of all federal recreation sites (PDF)</u>, including national parks, where the passes are issued.

U.S. citizens or permanent residents of the United States that have been medically determined to have a permanent disability (does not have to be a 100% disability) may get a free, lifetime pass that provides admittance to more than 2,000 recreation sites managed by five Federal agencies, including Lake Mead National Recreation Area. Access Passes are available online.

Required documentation: A copy of ID issued by an authorized U.S. agency such as your driver's license, passport or state-issued ID and documentation that proves permanent disability such as:

- Statement by a licensed physician (Statement must include: that the individual has a PERMANENT disability, that it limits one or more aspects of their daily life, and the nature of those limitations.)
- Document issued by Federal agency such as the Veteran's Administration, Social Security Disability Income or Supplemental Security Income
- Document issued by a state agency such as a vocational rehabilitation agency





A CHANGE IS MADE

As the American Legion Riders are near and dear to my heart, I thought it might be nice to reflect on the changes made to the National guidelines for the American legion Riders. These guidelines were generated and brought before the National Executive Committee at their virtual meeting conducted 5-6 May 2021.

As a little history, the American Legions Riders was established as a post level activity in 1993 by the Department of Michigan. The first chapter was at Post 396 in Garden City. It became a national program in 2007 via Resolution 35. Resolution 32 in 2011 amended Resolution 35. In 2020 another resolution – Resolution 19 – was generated as an "updated Program Guideline. Although not highly publicized, Resolution 19 created waves throughout the ranks of American Legion Riders throughout the states. As a result of the contentiousness of resolution 19, the National Organization did a relook at Resolution 19 and at the NEC virtual meeting on 5-6 May 2021 replaced it with Resolution B.

In an attempt for brevity, only the "Resolved" portion of the resolution will be provided in total below. Although the resolution brings clarity to the guidelines, there will be further guestions as the various chapters work to bring their organizations in to compliance with the new guidelines. In the mean time here is what the chapters will be utilizing to organize and continue their mission.

RESOLVED, By The National Executive Committee of The American Legion in regular meeting assembled virtually on May 5-6, 2021, That all American Legion Riders (ALR) groups be organized as programs supported by a post, department or other duly constituted department governing body of The American Legion and shall uphold the declared principles of The American Legion as well as conform to, and abide by, the lawful regulations and decisions of their department, post and/or other duly constituted department governing body; and, be it further

RESOLVED, That because The American Legion owns, controls, protects and defends The American Legion's intellectual property, composed of trademarks, emblems and copyrights (Emblem or Emblems), the following guidelines are required to fulfill protective standards:

- 1. All members of the ALR shall be current members of The American Legion, Sons of The American Legion or American Legion Auxiliary.
- 2. Each ALR member shall establish and maintain ALR membership by owning, individually or through marriage, a common-law marriage, a life partnership or a long-term relationship, a motorcycle licensed and insured as required by the ALR member's state laws.
- 3. ALR programs may allow for continued ALR membership for those ALR members who have given up motorcycle ownership because of age, illness, injury or other reasons outside the ALR member's control.
- 4. ALR programs may allow current members of The American Legion family to join ALR chapters as supporting members.
- 5. The only approved titles for ALR officers shall be chairman and vice-chairman or director and assistant director.
- 6. All ALR members shall maintain the image of The American Legion, protect The American Legion's Emblems, which symbolizes the integrity and principles of The American Legion and if wearing Emblem items then the Emblem items will be American Legion authorized emblems.
- 7. ALR members' vests should display the integrity, principles and values of The American Legion and the ALR by avoiding patches or pins with (1) explicit or offensive language and/or images and (2) political or partisan language and/or images since The American Legion is a non-partisan organization.
- 8. The ALR chapter should strive to represent the virtues, values, ethics and morals of The American Legion in support of freedom, democracy and the safety of our citizens. (cont. page 17)



LEGIONNAIRE INSURANCE TRUST Dear TAL Department of Nevada Members,

We wanted to provide an update to you all about Nevada Girls State:

TAKING INTO ACCOUNT A NUMBER OF FACTS, WE HAVE DECIDED TO CONDUCT THE 2021 SESSION OF NEVADA GIRLS STATE VIRTUALLY.

As this is the case, the total <u>cost per delegate</u> will be <u>\$250</u>.

We understand that the \$250 may seem like quite a bit. For that cost, we will be doing two major things.

Each participant will receive a package of goodies that they would normally receive during the session, such as a t-shirt, stickers, flags, and a poppy-making kit.

Most importantly, each participant will receive a \$25 daily meal allowance (\$125 total) and the ability to order food each day for delivery via DoorDash. We feel that this is very important because we understand that we do have delegates who are food insecure and, for the week of their participation, we can ensure that they have at least one good meal each day.

Of course, we would also like to provide you with some information on how we came to this decision. The following items contributed, though this is not an exhaustive list:

Delay in camp contracting. In normal years, we contract with the camp in November or December. Due to the ongoing challenges posed by COVID-19, UNR was unable to truly begin the contracting process until about late April.

Insurance. We have learned that neither our current insurance provider nor any other offers coverage for infectious diseases. Without such coverage during a pandemic, we could potentially be open to significant liability.

Buses. With the need to maintain social distancing, we would have needed to contract a third bus, significantly increasing our costs.

Low registration. Due to the varied nature of school attendance this year and the unique challenges that presented for reaching students, we are experiences lower-than-expected registrations. In order to use the camp per contractual requirements, we must pay for a minimum of 50 overnight guests. Additionally, in order for the program experience itself to work effectively, we must have at least 50 delegates.

As always, we still need your assistance to reach out to schools and provide them with information. If there are students who would like to attend but are faced with a technological barrier (such as not having a computer), we can provide options for them.

We're happy to answer any questions you might have. Feel free to call or email any time.

- 9. Per NEC Resolution No. 37, May 4-5, 1988 ALR chapters do not have the authority to enter into any formal association or club/council membership with any outside organization that may act or vote in any manner outside the control of The American Legion.
- 10. All ALR members shall obey the laws of their respective state and/or the state(s) in which they ride.
- 11. The ALR chapter's sponsoring organization (post, district and/or department) are strongly urged to review liability insurance coverage to ensure that adequate insurance coverage is available to insure/cover the sponsoring organization, including insurance coverage for any specific special riding event; and, be it further

RESOLVED, That American Legion Riders programs shall abide by the American Legion National Constitution and National By-laws as well as their established post, district and department directives; and, be it further

RESOLVED, That American Legion National Headquarters and the respective departments shall maintain general oversight of the American Legion Riders program in regard to proper use of the Emblems of The American Legion, the American Legion Riders and the American Legion Legacy Run and to ensure compliance with the American Legion National Constitution and National By-Laws; and, be it finally RESOLVED, That Resolution No. 19 (NEC, Oct. 2020), Subject: "Updated Program Guidelines for the American Legion Riders (ALR) National Program" is hereby superseded and rescinded.
