#### Students gifted copies of U.S. Constitution

#### Happy New Year Legionnaires

To continue with the History and Traditions of The American Legion. We left off with The American Legion Riders history and will continue with the rest of the 1990's...

Riders in Iowa have formed and honor guard called The Five Star Freedom Riders, and Riders in Mulvane, Kan., founded the Patriot Guard to protect the sanctity of military funerals from protesters. Riders in all states have escorted military units returning home from combat tours overseas, conducted massive cross-country fundraising events for wounded warriors from all services, and have raised millions of dollars for countless local, state and national charities. Many Riders, supported by their departments, conduct annual statewide Legacy Runs in dire support of American Legion scholarship programs of Operation Comfort Warrior (OCW), supporting our wounded service members across the nation.

True to the Legion's grassroots tradition, each chapter manages its programs at the post level, where the best ideas are born. The Riders are part of many projects and events, Including:

- Rolling Thunder, the annual POW/MIA rally in Washington on Memorial Day weekend.
- Annual regional rides such as Operation Wounded Warrior, sponsored by Riders in Nevada, Texas, New Mexico, Utah, Arizona, California and other Western states.
- Local charity events in support of The American Legion and local communities.
- Raising money for VA hospitals, women and children centers, children and youth centers, schools and other facilities.
- Sponsoring or participating in motorcycle runs to benefit numerous charities.
- Local memorial ceremonies and community parades.
- The American Legion Legacy Run, an annual cross-country fundraising ride from National Headquarters in Indianapolis to the national convention city.
- Riding to honor fallen military men and women, and protect the sanctity of their funerals from those who would dishonor their memory.
- Escorting military units to departure airfields and airports for combat tour overseas, and welcoming them home upon their return.

#### 1990's continued:

Aug. 1994 - The Legion announces the creation of the Citizens Flag Alliance, a coalition of organizations and individual citizens united to work for a constitutional amendment to protect the U.S. Flag from physical desecration.

Sept. 1994 - The American Legion announces partnership with the Smithsonian Institute's Air and Space Museum to develop and exhibit for the bomber Enola Gay.

Oct. 1995 - The Legion forms the Persian Gulf Task Force to aid veterans with illnesses from that war.

Sept. 1996 - The Legion awards a \$20,000 college scholarship to each of the 10 inaugural Samsung American Legion high school scholars.

Jun. 1997 - The National Emergency Fund surpasses the \$1 million mark in cash grants given to flood victims who belong to the Legion Family.

Sep. 1997 - The Legion presents its first National Law Enforcement Officer of the Year award at the 79th National Convention in Orlando, Fla.

Next month I'll begin the 2000's. All references for the Legions history come from Legion.org.

#### **Imposter Scams**

#### Here's how they work:

You get a call or an email. It might say you've won a prize. It might seem to come from a government official. Maybe it seems to be from someone you know – your grandchild, a relative or a friend. Or maybe it's from someone you *feel* like you know, but you haven't met in person – say, a person you met online who you've been writing to.

Whatever the story, the request is the same: wire money to pay taxes or fees, or to help someone you care about.

But is the person who you think it is? Is there an emergency or a prize? Judging by the complaints to the Federal Trade Commission (FTC), the answer is no. The person calling you is pretending to be someone else.

#### Here's what you can do:

- Stop. Check it out before you wire money to anyone. Call the person, the government agency, or someone else you trust. Get the real story. Then decide what to do. No government agency will ever ask you to wire money.
- Pass this information on to a friend. You may not have gotten one of these calls or emails, but the chances are you know someone who has.

#### **History: American Legion Oratorical Contest**

One of the major programs that is supported by the American Legion under Family and Youth is the Oratorical Contest. It is a constitutional speech contest that has been around since 1938, which has and continues to develop knowledge and appreciation for the United States Constitution among high school students. For over 80 years, this constitutional speech contest has educated youth on our national's founding documents, with an emphasis on citizenship. More than \$3 million in scholarships have been awarded over the history of the contest.

This program has presented participants with an academic speaking challenge that teaches important leadership qualities, the history of our nation's laws, the ability to think and speak clearly, and an understanding of the duties, responsibilities, rights and privileges of American citizenship. Over the years numerous politicians and prominent contestants have participated. Some of who were former presidential candidate Alan Keyes, national television commentator and talk radio host Lou Dobbs, and former U.S. Vice President Mike Pence.



For high school students looking to earn money for college this contest affords young orators a chance to participant in one of the most generous college scholarships available. Over \$203,500 in scholarships can be awarded each year. The overall national contest winner gets a \$25,000 scholarship. Second place takes home \$22,500, and third gets \$20,000. Each department (state) winner who is certified into and participates in the national contest's first round receives a \$2,000 scholarship. Those who advance past the first round receive an additional \$2,000 scholarship. The American Legion's National Organization awards the scholarships, which can be used at any college or university in the United States.

Each American Legion Department is representative at the National Contest.

This year's Department Oratorical is going to be held on February 5, 2022 at 9 a.m. – Western Nevada College, Carson City, NV in Marlette Hall, Cedar Building. Please if you can stop by and let's show these amazing participates our support.

#### What if I don't feel ready for treatment?

You may never feel truly ready to get help for PTSD, but if you're having symptoms, it's better to get treatment now than to wait. Not wanting to talk or think about the trauma can be a symptom of PTSD. The sooner you get treatment, the sooner you can start to feel better.

#### It is a new year and there are things in the Department of Nevada 2022 membership world for us to celebrate!

**Post 10 in Las Vegas is the first Post in the Department to exceed 100% of 2022 Goal.** Those Posts who lead the charge to 100% are Post 32 in Carlin at 93%; Post 27 Sandy Valley at 85%; Post 16 in Fallon at 83%; Post 37 Fernley at 80%; Post 5 in Winnemucca at 80%. All of these Posts with the exception of Fallon, would be considered our smaller Posts but certainly active ones. Of the larger Posts with goals exceeding 300 members, those Posts should also look at the positive in the numbers that they have. Although all of the larger Posts are mostly over 70% of goal their renewal rate reflect large numbers. Post 1 Reno has renewed 168 at a renewal rate(RR) of 72%; Post 8 renewed 451 at RR 74%; Post 40 Henderson renewed 575 at RR 78%; Post 60 Laughlin renewed 201 at RR at 80%; Post 76 Las Vegas renewed 401 at RR of 70%; Post 149 renewed 189 at RR75%; Post 4 Carson City 169 at RR79% . These are all big numbers.

#### Other Posts with high RR are Post 24 Mesquite RR 86%; Post 31 Boulder City RR 82%; Post 16 Fallon RR 80%.

Posts that have recruited new 2022 members beyond 1 or 2 are Post 16 Fallon 13 new members; Post 19 Hawthorn 5 new members; Post 8 Las Vegas 10 new members; Post 10 Las Vegas 26 new members; Post 40 Henderson 34 new members; Post 60 Laughlin 7 new members; Post 76 Las Vegas 21 new members and Post 149 Las Vegas 10 new members.


Every Post should be recognized for their efforts to bring in new members even those that have brought in 1 or 2 new members. When you meet a veteran who is not a member of the Legion, **JUST ASK them to join and carry an application with you.** 

As we can see, there has been progress in all the Department Posts to achieve a 100% RR as soon as possible. There is good work being done but it is clear we can't give up our continuing efforts to get those renewals. If you want more ideas of how to be in contact with your past members, the Legion is loaded with ideas. JUST ASK!! Look to My Legion Resources and/or your District's officers as the place to start.

Use of DMS and Post 100 is encouraged to increase Post member numbers. Be sure you obtain consent to make the transfer to your post. The consent can be in writing, signature, email, text or phone call.

Engagement with individuals within Posts is the most powerful tool to make members feel they are important to the Post and the American Legion.

Think about WHY you joined the Legion and be ready to tell non-members what the Legion is and does.

ELKO — This year's Festival of Trees auction raised \$31,110 which was distributed to the four Charity Partners selected by the Elko Convention & Visitors Authority board of directors. The 2021 Charity Partners — Elko Hockey Club, Elite FC, Zero Suicides Elko County and the Community Foundation of Elko County — were each awarded \$7,777.50 this week. "The Festival of Trees never disappoints," said Katie Neddenriep, executive director of the ECVA. "The community came out bigger than last year, contributing 129 items to the auction. The Conference Center had several school groups come through and steady visitation throughout the four days of the event.

"It was nice to not have the restrictions we faced last year, and the ECVA team did a fantastic job presenting a hugely successful event," said Neddenriep.

This year's theme was My Favorite Things. Auction items were available for in-person and online viewing Dec. 1-4. While no gathering restrictions were in place, there was still uncertainty around how many items would be contributed to the auction and the amount of funds to be raised. Based on these factors, and a desire to provide impactful funding for programming and services in the community, the ECVA Board selected only four charity partners, same as 2020, though fewer than previous years.

The ECVA is encouraging the community to participate in the 2022 Festival of Trees at the Elko Conference Center.
